5. Live Foal Guarantee:

Not Included – No live foal guarantee is offered due to the nature of frozen semen.

6. Mare Owner Responsibilities:

Mare Owner agrees to use a qualified reproductive veterinarian.

Pregnancy status must be reported by November 1st, 2025, and must include:

Date(s) of AI (artificial insemination)

Copy of the mare's registration papers

7. Liability:

No warranties are made regarding semen fertility, conception, or resulting foal.

Semen Owner is not liable for loss, delays, or damage once semen has shipped.

All risk passes to Mare Owner at time of shipment.

8. Term & Termination:

This agreement is valid through December 31, 2025.

Either party may terminate in writing. No refunds will be issued after semen has shipped.

9. Dispute Resolution:

This contract is governed by the laws of the Province of Alberta.

Any disputes will be resolved through arbitration or small claims court in that jurisdiction.
